Building Inspection Request Form

Email this completed form to **inspections@peachland.ca** to request your inspection. Inspections are normally done the next business day, but allow up to 48 hours. Morning or afternoon accommodated subject to availability. Inspections will not be booked later than 2:30 pm.

For all inspections: all required work must be complete. Permit placards must be posted and visible. Approved drawings & requested documents must be available on site AT THE TIME of inspection. All changes must be submitted and approved prior to commencing work.

WorkSafeBC required site safety protocols must be in place: i.e. stairs, hand and guard rails installed; stone slingers and other noise or dust producing operations must be temporarily paused.

Incomplete or covered work, or an unsafe site will not be inspected and is subject to a \$50 re-inspection fee.

Driveway Permit Final Inspection: Only request when ready to operations@peachland.ca. Allow up to 2 business days.	
Final / Occupancy: ALL WORK MUST BE COMPLETE. Conditional or provisional occupancy NOT available. Final plumbing must be accepted. Schedule C-B's, Insulation Installer Certificate, and CEA reports required.
