### BYLAW NUMBER 701

A BYLAW to Regulate the Use of Any Explosive Agent for Blasting in the Municipality of Peachland

WHEREAS by virtue of the provisions of Section 871(1)(b) of the <u>Municipal Act</u>, Council may, by Bylaw, regulate or prohibit the use of explosive agents within the boundaries of the Municipality of Peachland;

AND WHEREAS it is considered desirable and expedient by the Peachland Municipal Council to regulate the use of such explosive agents;

NOW, THEREFORE, the Peachland Municipal Council, in Open Meeting assembled, ENACTS AS FOLLOWS:

- 1. The use of any explosive agent for blasting shall be by Special Permit.
- 2. No person shall be granted a Special Permit unless they hold a current and valid Blaster's Certificate for British Columbia indicating such a person is knowledgeable, or certified, to handle and detonate explosive agents for blasting.
- 3. All persons granted a Special Permit shall be required to produce a valid certificate(s) of insurance, performance bonds, and/or security for damage to person(s) who, or whose property, may be injured hereby.
- 4. Any person guilty of an infringement of any of the provisions of this Bylaw shall, upon summary conviction, be liable to a penalty of not less than One Thousand Dollars (\$1,000.00) for the first offence, and to a penalty of no less than Five Thousand Dollars (\$5,000.00) for each subsequent offence.
- 5. This Bylaw shall be cited for all purposes as the "Regulation of Explosive Agents Bylaw Number 701, 1970".
