In the District of Peachland, short-term rental (anything under 30 days) of a private room or a suite in a home is regulated under the Zoning Bylaw as Bed and Breakfasts. There are two types of Bed and Breakfasts:

- Traditional Bed and Breakfast with an individual room and a shared living facility, and
- 2. Suite Bed and Breakfast

Short-term rental of an entire dwelling, including a garden suite or recreational vehicle, is not allowed in Peachland.

The operator of the bed and breakfast must have a business license and the rental must be operated at the licensee's principal residence.

It is important that short-term rentals do not adversely affect the community. A short-term rental must meet specific health and safety standards. The property will require a building and fire inspection before a business licence is issued.

Changes to Parcel Taxes

Residents will notice changes to Parcel Taxes on their 2024 property tax notice as the District introduces new parcel taxes, concludes others and rolls some into general taxes.

On February 27, Council gave first three readings to these parcel tax bylaws:

- \$40.48 Regional District of Central Okanagan Westside Regional Transfer Station Parcel Tax Bylaw No. 2413, 2024 – for the provision of the transfer station service in West Kelowna available for Peachland residents,
- \$129.07 Phase 1-D and Phase 2 Sewer Collection Specified Areas Parcel Tax Bylaw No. 2414, 2024 - to facilitate repayment of debt by 2023,
- \$199.60 Water Treatment Plant Debt Servicing Parcel Tax Bylaw No. 2415, 2024; this is a 25-year debt undertaken in 2022.
- \$50.00 New Fire Hall Project Implementation Parcel Tax Bylaw No. 2416, 2024, a new parcel tax to finance the planning and design of the new fire hall.

Four debts have now been fully recovered and will not be brought as parcel taxes in 2024; Downtown Revitalization, Turner Park Debt Servicing, Beach Avenue Sewer Collection System, Sewer Force Main.

Four parcel taxes will be transferred to the General Tax levy. The parcel taxes were put in place to build reserves for asset renewal and capital expenditures. These are ongoing needs and should be levied based on property assessments, in line with the Community Charter. The General Capital Asset Renewal, Sewer Capital Asset Renewal, Water Capital Asset Renewal and Water Capital Improvement parcel taxes will be transferred to general taxes for 2024.

Yard waste pick up resumes March 1



OPEN BURNING

Please read this BEFORE lighting that brush pile!

In Peachland, permits are required before any OPEN BURNING can be done, and these fires are only allowed on a residential property that is 1 hectare (2 1/2 acres) or more. Also, you can NEVER burn compostable materials like leaves, grass or pine needles. Permits are granted after every reasonable alternative to remove wood debris has been pursued. Only cured, dried wood can be burned and only on proper venting days when open burning is allowed. Find out more at www.peachland.ca/

Peachland Graffiti Features a Pig Roast & Sock Hop! Saturday, April 20





Water Restrictions Bylaw Updated

Council approved a Water Restrictions Bylaw that now allows Stage 2 Watering Restrictions to be initiatived by the Director of Operations, rather than requiring a Council resolution to



Stage 1 restrictions are always in effect in Peachland.

These restrictions require properties to water as follows: even -numbered addresses on even calendar days and odd-numbered addresses on odd calendar days, allowing for watering 3-4 days of the week. Stage 2 restrictions would reduce outdoor watering to twice a week; with even numbered addresses permitted to water on Saturday and Tuesday and odd-numbered address on Sunday and Wednesday. With drought conditions possible this year in the Okanagan, water restrictions may be required depending on the availability of water in Peachland's primary source for potable water, Peachland Lake. Further stages of water restrictions would still need to be enacted by Council.

Mayor's Message

Welcome roadwork on the horizon

What I'm sure will be happy news for many residents, spring will bring some welcome roadwork in Peachland, with some of our upper roads getting some TLC.

This year, will be targeting arterial and collector roads and, as the budget stretches, look at some local road improvements as well. The assessment of priority areas is underway to see how far we can stretch our 2024 roads

rehabilitation budget of \$1.15 million (\$550,000 carry-over from 2023 plus \$600,000 from the 2024 budget request).

Princeton Avenue is a Council priority and problem areas will be considered for some road rehabilitation in 2024. Also noteworthy, some of this year's budget is reserved for Thorne Road as part of the rezoning file Z22-04, the District is contributing up to \$59,000 towards improvements.

Sidewalks expansions are not planned for 2024, however Council did provide preliminary approval in the 2024 budget to start an active transportation reserve fund of \$30,000/year, saving up for sidewalk infill and expansions.
