#### THE NATURE OF OUR BUSINESS

The fire and rescue service is one of today's most diverse and challenging professions. This inspires men and women to enter the service, as volunteers, *paid-on-call* or career firefighters. Imagine having to train to prepare yourself to cope with situations that range from structure fires to motor vehicle accidents to hazardous chemical spills to heart attacks and any other possible emergencies. These skills are required at any time of day, seven days a week, in any weather, and very often under potentially stressful and emotional circumstances. These factors contribute to our profession being personally very rewarding.

Our primary goal is to protect the public. We accomplished this in two ways:

- 1. The first is to prevent fire emergencies from occurring through fire prevention, inspections, fire safety education and code enforcement programs.

#### **Mission Statement**

To provide the most effective and efficient fire protection and rescue service for the citizens of and visitors to the District of Peachland.

#### **Profile**

The Peachland Fire and Rescue Service is a paid-on-call department.

#### Organization

The Peachland Fire and Rescue Service operates under the direction of the Fire Chief who is responsible to the Regional Board of the Regional District of Central Okanagan and the Peachland Municipal Council.

In order to deliver the services needed to accomplish the above-stated mission statement, we have highlighted our department into four divisions as follows:

- Operations responsible for delivering emergency services for fire and rescue and backup emergency medical services.
- Fire Prevention responsible for inspections, plan reviews, permits, investigation, and public education.
- Administration responsible for finance, planning, logistics, and supporting other divisions.
- Training responsible for achieving and maintaining the skills and expertise to accomplish the PFRS stated mission.

#### Operations:

The Peachland Fire and Rescue Service responds to approximately 350 emergency calls per year, including structure fires, grass fires, wildfires, motor vehicle accidents, public services, and first medical responses.

#### Paid-on-call firefighters:

Men and women who are physically fit and wish to participate in emergency, fire, and rescue activities can apply for any opening. The minimum age is 19, and the Junior firefighter program is for ages 16-18.

#### **Training and Participation:**

Over the years, the Peachland Fire and Rescue Service has evolved into a public safety agency providing highly technical and diverse services. The public has come to rely on the fire department as the "first responder", not only when natural disasters threaten lives and property, but for seemingly smaller problems as well.

To ensure that all PFRS members are prepared to deliver the best level of services required, training standards provide each member with the skills, knowledge, and abilities necessary to deliver fire and emergency first aid service to the citizens of Peachland.

#### Training Requirements - Recruits and Probationary Firefighters:

All *paid-on-call* members entering the PFRS, regardless of prior training or experience, must complete a 6-month probation period and 60 training hours before being accepted as full members of the PFRS.

#### Firefighters:

All recruit *paid-on-call* members of the PFRS are expected to achieve the minimum level of exterior firefighting. New members must attend a minimum of 70% of the weekly practices calculated using a 3-month rolling average and 25% of incident callouts during their first two years of service. Attendance at occasional weekend courses and public service events is also required. Those who demonstrate a desire to increase their skills may be provided with the opportunity for advanced training in subjects such as marine rescue, rope rescue, and auto extrication.

#### GENERAL DUTIES AND REQUIREMENTS - PAID-ON-CALL FIREFIGHTER

#### Nature and Scope of Work

PFRS firefighters are responsible for combating, extinguishing, and preventing fires and saving lives and property within the District of Peachland. They participate in training as required by the PFRS training program and in inspections and fire prevention programs as assigned.

All members must be physically and mentally capable of responding to an emergency to perform firefighting/rescue and other related work as required to save lives and property.

Summary of Firefighter Duties, Responsibilities, and Working Conditions:

- Fire department members must reside within our fire protection district.
- Covered by WorkSafeBC and On-Duty Accident & Sickness Insurance.
- May be required to obtain a Hepatitis 'B' vaccination or provide confirmation of current vaccination.
- Must maintain a reasonable level of health and fitness.
- Must carry a pager supplied by the Fire Department.
- Must obtain First Aid and CPR certificates (training provided by the department).
- Must complete a Recruit/Exterior Training Program before activation.
- Must be committed to continuous training in fire suppression, auto extrication, and emergency first aid procedures.
- For safety reasons, facial hair may affect the integrity of the self-contained breathing apparatus's facepiece seal. Beards, bushy moustaches, and long sideburns are not permitted.
- Responsible for performing various duties safely and efficiently under emergency conditions.
- Tasks include the routine maintenance of firefighting equipment and property, carrying out specific orders and directions as received from a superior officer, training, and firefighting.
- Must respond promptly, safely, and efficiently to alarms, obey the orders of the officer in charge, and share in the work required at emergency scenes, around the fire station, and when otherwise on duty.
- Must refrain from using offensive statements or language at the emergency scene, in and around the fire stations, and when on duty in public.
- Must be loyal to their fellow firefighters, officers, and department and always conduct themselves professionally, compassionately, and sensitively, remembering that he/she is in the eyes of the public while on duty or when wearing identifiable department clothing while not on duty.
- Must meet minimum attendance for calls and training.
- Zero tolerance for members engaging in any fire department business while impaired by drugs or alcohol.

#### QUESTIONS ASKED MOST OFTEN BY PROSPECTIVE PAID-ON-CALL MEMBERS

- Q. What is the cost of the required training?
- A. The PFRS provides training for paid-on-call firefighters free of charge.
- Q. How much will I have to pay for my protective clothing?
- A. The PRFS provides all required protective clothing at no cost to the individual.
- Q. What is the format of the paid-on-call member's training schedule?
- A. Training is every Monday night and may include some full-day weekends.
- Q. Who provides insurance coverage for my activities as a paid-on-call firefighter?
- A. Normal Workers' Compensation Board coverage is in effect whenever the individual is working for the PFRS. The Municipality of Peachland also has insurance coverage for auto liability when operating PFRS vehicles and accidental death and disability coverage. The PFRS also has a special life & AD&D insurance policy for all members, providing 24-hour coverage for the member. For an additional fee, the member's family may also receive 24-hour coverage.
- Q. Are paid-on-call firefighters directly paid in any way?
- A. Paid-on-call firefighters are paid for required training and all emergency call-outs at the rate set by the District of Peachland PFRS budget.
- Q. After my initial training, how much time will I be expected to give as an active member?
- A. While there are no exact time requirements, the average training and call-out time is approximately 20 hours per month. There is no ceiling on how much you can participate.
- Q. How often will I be on call to respond to emergencies?
- A. Our system depends upon paid-on-call firefighters being available to answer all emergencies. The PFRS, therefore, expects that paid-on-call firefighters, when in the District of Peachland, will be on call 24 hours a day, seven days a week, 365 days a year. This significant commitment needs careful consideration before you undertake it. The PFRS realizes that no one can always be available, but it relies on the commitment of paid-on-call members to respond whenever they are available. Potential members should be aware that this commitment cannot be taken lightly; their response to emergencies is a lifeline to the public they serve.

- Q. How quickly will I have to respond to emergencies?
- A. The PFRS would normally expect all available members to respond immediately to a page out. Our policy calls for paging a second call if we have not had a response within three (3) minutes. Normally, the first apparatus is en route within that time.
- Q. How long do emergency call outs last?
- A. The average call-out lasts less than an hour. A working structure fire may extend to 3 to 4 hours. Major, multi-alarm fires may last 8 to 10 hours. Very rarely, a major emergency may extend for days.
- Q. If I have prior fire/rescue training and experience, will it count towards the district's training requirements?
- A. Prior training will likely reduce the time necessary to develop the minimum skills the PFRS looks for in its paid-on-call firefighters. However, participation in all programs is still required to demonstrate your proficiency.
- Q. It is possible for me to concentrate my participation and specialize in one area of fire PFRS response?
- A. All paid-on-call members are generalists, capable of doing any of the fire or rescue tasks that may occur in an emergency. Specialist training is provided, but not to the exclusion of the requirement to be able to participate in all PFRS activities.
- Q. Is there a medical and physical examination prior to acceptance by the PFRS?
- A. There is a medical and physical examination. Your doctor must complete a form provided by the PFRS.
- Q. Will there be written or physical tests prior to acceptance by the PFRS?
- A. Yes. You will be required to perform a series of physical tests to ensure that you are capable of doing the task required as a firefighter.
- Q. Can a woman be a firefighter with the PFRS?
- A. Yes. We currently have several women firefighters.
- Q. Is there a social aspect to belonging to the PFRS?
- A. Yes. In addition to contributing to the community, firefighters often find personal satisfaction in belonging to the PFRS. Members participate regularly in fire station socials and PFRS-related activities such as hose coupling competitions and community projects.

- Successful completion of a physical fitness test administered by the fire department.


